



# Elementary Schools Phase 4 Reopening Plan

### Transportation

Busing is available. Students will sit one child per seat. Children from the same household may sit together, two to three to a seat. Providing your own transportation is encouraged. Buses will be sanitized between each run.

**All students must wear masks on the bus.**

### Masks

- Masks do not have to be worn in the classroom unless social distancing cannot be maintained.
- Masks will be worn during transitions and when social distancing cannot be maintained.
- Masks do not need to be worn outside as long as social distancing practices are in place.
- Staff is required to wear masks at all times.
- Students with medical conditions preventing them from wearing masks must submit a Doctor or Physician Assistant note of exemption. A meeting with Administration will be held to determine educational placement.

### Wellness Checks

Parents are expected to monitor their children for illness prior to sending their children to school. Monitor for the following:

- Fever greater than 100.4°
- Cough
- Runny or congested nose
- Tired and/or achy
- Shortness of breath
- Vomiting and/or Diarrhea
- New loss of taste or smell

If you notice any of these changes, you may want to contact your healthcare provider

## Health and Safety

- **COVID-19 Positive Protocol**  
Should a student or staff member contract COVID-19, the Calhoun County Public Health Department will work with HCCS to determine steps to be followed.
- **Visitors and Volunteers**  
Visitors and Volunteers will not be allowed at this time. If you are coming into the school you will be asked a quick series of health questions. Access may be denied.
- **Signs of Illness While at School - student or staff**  
Person will be moved to an isolation room and sent home as soon as possible. They will be encouraged to contact a healthcare provider and may not return to school until quarantine and fever-free period has been completed.
- **Cleaning Protocol**  
Desks will be cleaned at least every four hours. Rooms will be cleaned using an electrostatic cleaning system daily. Drinking fountains are shut off.

## Classroom and School Environment

### Meals

- Breakfast and lunch will be served in the classrooms.
- Students are encouraged to bring their own water bottles daily.

### Activities and Schedules

- PE will be held outside when possible.
- The playground will be available for recess with their classroom.
- Specials Teachers will go to the classrooms.
- After-school clubs and activities will be allowed. Clubs may meet virtually.

### Classrooms

- Classes will be smaller allowing for desks to be spaced further apart.
- Students will go directly to their classrooms when they arrive.
- Supply sharing will be minimized.

### Open Houses and Conferences

- Open Houses and Conferences will be held virtually.
- Appointments will be available to tour the buildings prior to the start of school. Teachers will not be present.
