- I. Call to Order: The meeting was called to order by President Bess at 5:00 PM.
- II. Pledge of Allegiance: Mr. Bess led the Pledge followed by a moment of silence.

 - A. Non-Union Pay Scale: Mr. Ridgeway discussed the Office of Retirement Services law addressing the salary schedule for non-union District job classifications. Mrs. Obermyer and Mr. Ridgeway issued a schedule to employees in non-union jobs to ensure compensation increases for employees in these roles. The increases are governed by individual employment agreements.
 - B. Ratification of Transportation Contract: Mr. Ridgeway and Ms. Obermyer meet with the Harper Creek Transportation Association to discuss the contract. There were no changes made from the discussion at the June 10, 2024, Board of Education meeting. Mr. Ridgeway recommends ratifying the Harper Creek Transportation Association contract. This is a three-year agreement.
